

Purpose

The Skate Oakville Jump Grant program is designed to provide incentive to skaters who achieve successful jumping skills on competitions. The Jump Grant program is for Skate Oakville members in good standing, representing Skate Oakville as their home club.

Application

Completed applications must be submitted by the stated deadline date and submitted with Competition Report Cards highlighting the successful jumping skill. Please attach report cards to the original application. All required documents are available on the websites of the hosting Sections. The Bursary dates will be a full 12-month period starting May 1st and ending April 30th the following year.

The Skate Oakville office will not be responsible for maintaining individual skater records or copies of report cards for the purpose of bursary applications. All information required is available on the competition or events portion of the websites of the hosting Section. Please make sure you compile the information during the season as the Sections may remove it after competitions or at the end of each competitive season.

In an attempt to provide timely and responsive service, bursary applications must be received by the deadline specified on the application.

Criteria

The Skate Oakville Jump Grant Bursary program is designed to provide incentive and recognition to skaters achieving jumping skills relative to their competitive level. The Jump Grant program is for Skate Oakville members in good standing, representing Skate Oakville as their home club and registered in a complete Skate Oakville Competitive Program (Elite / Comp A – 3 days on and off ice).

The element must be completed on one foot and verified by the technical panel in order to qualify for a grant. This will be verified by the report card. If the element has one of the following mistakes (as determined by the technical Panel) the skater will not be eligible for the scholarship: under rotation, incorrect edge takeoff, downgraded jump and GOE of -2 or -3.

Types of Events

The Jump Grant Bursary applies to Competitive and Qualifying competitions including: Scarboro Skate, Summer Sizzle (WOS), Summer Competition COS), Detroit Summer Competition, Minto Competition (EOS), Isabelle Henderson, Octoberfest, Sectionals (COS) and STARSkate Championships.

The chart below indicates the elements for each competitive category. For the Pre-juvenile, Juvenile, Pre-novice and Novice the skater is not yet ready to start the element from a developmental standpoint (too early or young). In the case of Junior or Senior, these elements should already be part of the skater's program.

Please address your request to Skate Oakville Bursary Committee. The Skate Oakville Bursary Committee is responsible for establishing and reviewing bursary policy and serving as the body to review decisions brought forward for appeal.

Deadlines

It is the responsibility of the skater and/or parent to submit the Bursary Application by the stated deadline.
